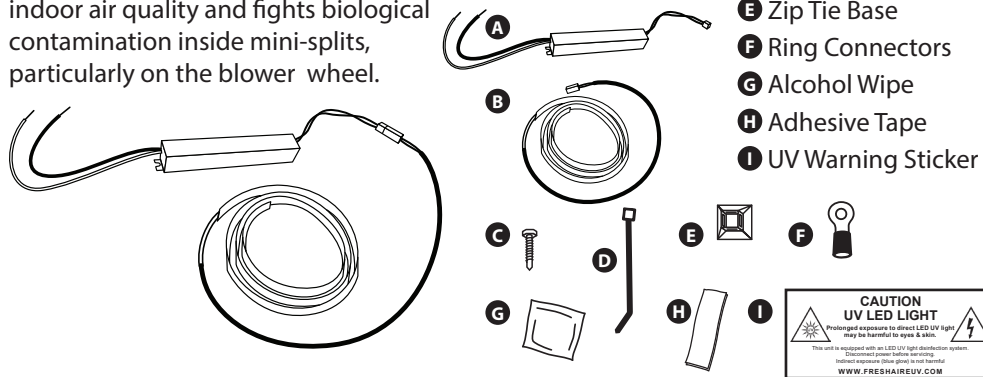


FRESH-AIRE MINI UV LED

Mini-Split Installation Instructions

Fresh-Aire Mini UV LED improves indoor air quality and fights biological contamination inside mini-splits, particularly on the blower wheel.

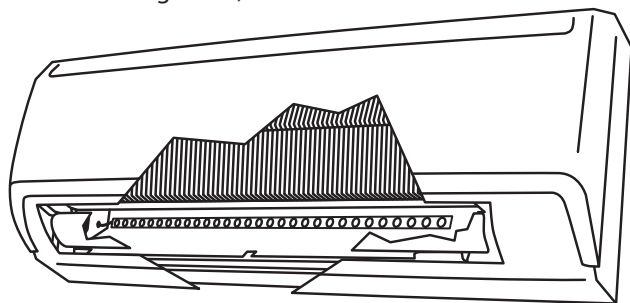

Installation Notes

Mini UV LED is typically used for mini split systems and other limited space applications. Because space is tight the best place for mounting the LED lights is usually inside the supply vent with the light shining onto the blower wheel (which is prone to the worst mold growth).

CAUTION UV LED LIGHT

Prolonged exposure to direct LED UV light may be harmful to eyes & skin. Disconnect power before servicing. Indirect exposure (blue glow) is not harmful.

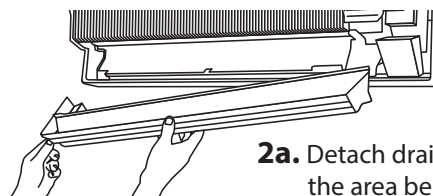


IMPORTANT!

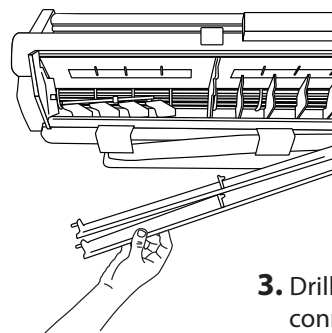
Install LED strip so that the light shines into the air system, not into the room.

Air System Preparation

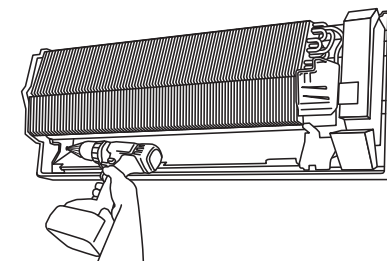
1. Remove cover.



2a. Detach drain pan to access the area behind it.



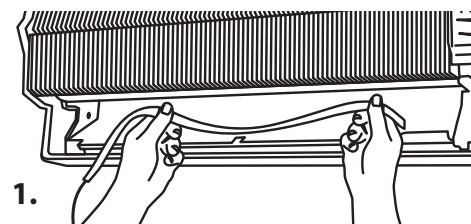
2b. For systems with non-removable drain pan, remove louvers and baffles to access the area behind.



3. Drill a 1/2" hole to pass connector cable through to back of unit as needed.

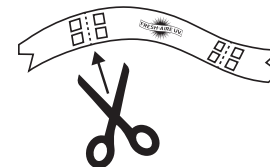
LED Strip Mounting

1. Determine the best location for the LED Strip and clean that area with the alcohol wipe.
2. If needed shorten the LED strip by 4" segments (**cut only between copper squares on strip**).
3. Pass the connector cable through the drilled hole.
4. Peel off paper from the adhesive backing on the LED strip a few inches at a time and press it down firmly onto the clean surface.

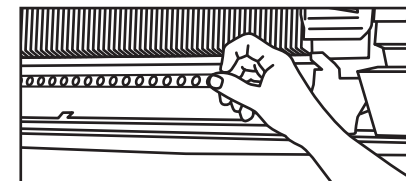

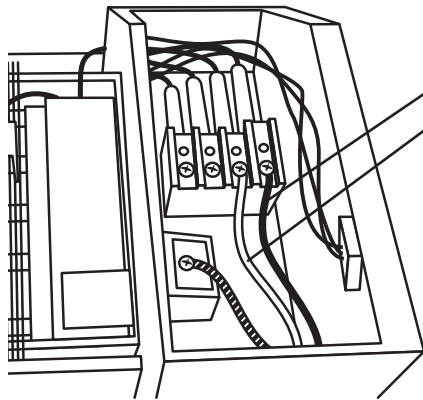

IMPORTANT!

Place the LED strip so the light will shine on blower wheel and mold prone areas, **NOT INTO THE ROOM.**

Power Supply Installation



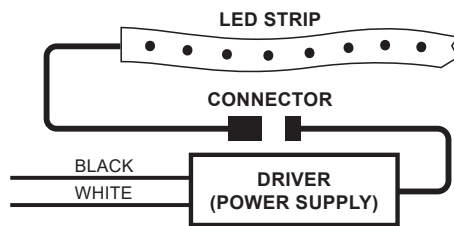
1. Remove the control box cover and connect the wiring harness as shown.

LED Driver wiring

- Black to hot terminal
- White to neutral (typically S1 & S2)

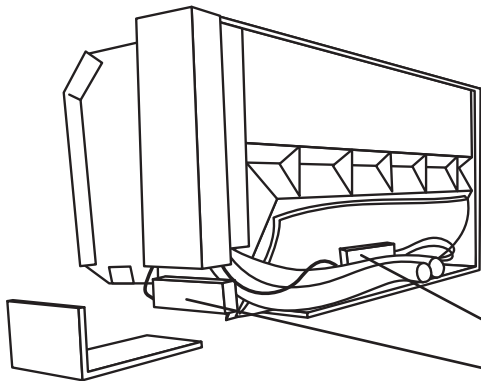
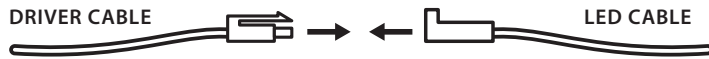
Note: Some indoor systems may require additional wiring to provide line voltage to the Mini UV LED power supply.

2. Wiring Diagram*



* Mini UV LED comes with a 120, 208, 240 VAC driver (power supply)

3. Insert the UV lamp cable connectors and wiring harness connector into the power supply.



4. Tuck the power supply into the line chase on the back of the ac unit or place it in or under the control box or other secure location.

5. Return power to the system and confirm that Mini UV LED is working.

6. Apply the UV warning sticker in an appropriate location.

This warranty does not cover parts damaged as a result of misuse, abuse, or any use other than its intended use, accident, acts of god, neglect, or from improper operation, maintenance, installation, modification or adjustments. Triatomic Environmental, Inc. shall have no responsibility for charges incurred by the customer for installation or removal of warranted items.

This warranty does not cover parts or equipment used with the Fresh-Aire UV system that are not manufactured by Triatomic Environmental, Inc.

Once the product is returned, we will inspect your product and contact you within 10 business days of our receipt of the product to give the results of our inspection. If we determine that the product is covered under this warranty, we will ship to you at no additional cost a replacement part. Replacement parts may be refurbished. If we determine that the product is not covered under this warranty, or that this warranty is void, the product will be returned to you COD. There is no charge for inspection.
